CPL revenue is used to support the business operation of maintaining the CPL database, the program used by the county clerks and the Michigan State Police (MSP) CPL Unit to enter applicant information and conduct background checks, and the CPL renewal website. It is used for compiling the CPL annual report to the legislature; developing, printing, and distributing required forms; providing training and support, and legislative and legal resources. In addition, CPL revenue, along with fingerprints and Internet Criminal History Access Tool (ICHAT) fees, is used to support several criminal justice information systems used by law enforcement and criminal justice agencies, including the MSP CPL Unit.
